1. **US Citizens DO NOT NEED A VISA to travel to Mongolia.**
2. **Please submit your valid/signed passport** (The passport must have at least one blank visa page for the visa and must be valid for 6 months from the end of your trip). Please contact us for information on renewing your passport, if needed.
3. One visa application form completed and signed.
4. One 2" x 2" passport size photograph on a light colored background
5. Proof of departure; i.e. computer generated flight itinerary from Asia Transpacific Journeys.
6. Non US citizens submit valid I-94 or a copy of your Alien Registration Card *aka Green Card*.

Please send this sheet with all fields completed; only one sheet is required per family.
