# Visa Requirements AUSTRALIA - E.T.A.

## Required Documents Checklist

ALL TRAVELERS must include the following documents in your package to G3:

- A clear photocopy or scanned image of the information/photo page of your valid signed passport. This may be emailed to [info@g3visas.com](mailto:info@g3visas.com) for faster processing.

### NOTES:

An Electronic Travel Authority (E.T.A.) visa may be issued to people of the following nationalities ONLY: United States, Canada, France, Spain, Andorra, Austria, Belgium, Brunei, Denmark, Finland, Greece, Germany, Hong Kong (SAR), Iceland, Republic of Ireland, Italy, Japan, Republic of Korea, Liechtenstein, Luxembourg, Malaysia, Malta, Monaco, Netherlands, Norway, Portugal, San Marino, Singapore, South Korea, Switzerland, Sweden, United Kingdom, and the Vatican City.

\*Short Term E.T.A. visas are valid for multiple entries to Australia within 12 months of the date of issue.

\*\*Long Term E.T.A. visas are valid for multiple entries to Australia until your passport expires. ( Available only for Business or Flight Crew.)

For visa requests requiring Same Day processing, G3 must receive all paperwork no later than 8:30 AM. Please send documents via FedEx or UPS with no signature required, or email your scanned passport image and completed Traveler Information form with credit card payment information to [info@g3visas.com](mailto:info@g3visas.com).

Send all required documents and the completed Traveler Information form to G3 using a service with tracking such as FedEx or UPS.
