

Required Documents Checklist

ALL TRAVELERS must include the following documents in your package to G3:

- Your original valid signed passport, plus one photocopy of the information/photo page. It must have one or more blank visa pages and more than six months before expiry.
- Non-US citizens must provide a copy of their Alien Registration Card (A.R.C.) or U.S. Visa and I-94.
- One completed and signed visa application form (see attached). The application must be typed; handwritten applications will be typed up by a G3 associate for an additional \$25 fee. Do not list Hong Kong, Macao or Tibet on the application. Please print the application double-sided. Non-US Citizens and applicants for Work or Student Visas must also complete the supplemental form.
- One passport-style (2"x2") photograph taken within the last 6 months. It must be on photo paper and have a plain white background.

BUSINESS TRAVELERS must also include:

- A business letter from their U.S. company. This letter must explain the purpose of the trip and provide a financial guarantee. It must be on letterhead and signed by a representative of the company other than the applicant. (A sample is attached.)
- A letter of invitation from the organization to be visited in China, stating the purpose of the visit. A sample is attached.

OFFICIAL VISA APPLICANTS must also include:

- A letter from the U.S. Department of State stating the nature and duration of the visit. You will need to submit your Official U.S. Passport (brown cover), not your Tourist Passport (blue cover).
- An official invitation issued by the appropriate Chinese government office.

STUDENT VISA APPLICANTS must also include:

- The original acceptance letter from the school you will be attending in China and Form JW202 issued by the Ministry of Education.

NOTES:

Applicants under 18 years old and current or former nationals of France, China, Hong Kong, Macao or Taiwan should contact G3 for further instructions and requirements.

Chinese visas will not be issued more than 90 days in advance of the scheduled entry date to China.

It is extremely difficult to expedite visa processing once an application has been submitted to the consulate. Requests to expedite the processing after the application has been submitted will result in significant additional charges.

If you are in need of a Flight Crew or Work visa, please email China@g3visas.com for instructions.

For visa requests requiring Mission Critical processing, G3 must receive all paperwork no later than 8:30 AM. Please send documents via FedEx or UPS with no signature required.
