

Required Documents Checklist

ALL TRAVELERS must include the following documents in your package to G3:

- Your original valid signed passport. It must have two blank visa pages facing each other and more than six months before expiry.
- Non-US citizens must provide a copy of their Alien Registration Card (A.R.C.) or U.S. Visa and original I-94.
- One completed and signed visa application form (see attached).
- One passport-style (2"x2") photograph taken within the last 6 months, on photo paper and with a plain white background.
- Copy of flight itinerary
- An official business or tourist invitation from the host in Kazakhstan. Invitations are not required for US, Canadian or EU citizens who request tourist visas or single entry, 30 day business visas. If you require more than one entry or will spend more than 30 days in Kazakhstan, G3 can assist in acquiring the official invitation; see details below. Please note that invitation fees and processing times are in addition to visa processing fees and times.

BUSINESS and FLIGHT CREW TRAVELERS must also include:

- A business letter from their U.S. company. This letter must explain the purpose of the trip and provide a financial guarantee. It must be on letterhead and signed by a representative of the company other than the applicant. A sample is attached.

WORK PERMIT APPLICANTS must also include:

- The official work permit invitation issued by regional authorities in Kazakhstan. Faxed or scanned copies are accepted.
- A copy of the permission for foreign labor recruitment, if the employment is not regulated by an international treaty or Republic of Kazakhstan agreement.

APPLICANTS UNDER AGE 18 must also include:

- A personal letter signed by the applicant's parents requesting that a visa be issued. This letter must list the purpose and dates of the trip and give contact information for the host in Kazakhstan.
- A copy of the applicant's birth certificate.
- A copy of the information page of each parent's passport.

NOTES:

The Embassy of Kazakhstan is closed every Wednesday. Please take this into account when choosing a processing speed.

For visa requests requiring Mission Critical processing, G3 must receive all paperwork no later than 8:30 AM. Please send documents via FedEx or UPS with no signature required.

Embassy Fees listed below include a \$5 Money Order fee.

Send all required documents and the completed Visa Order Form to G3 using a service with tracking such as FedEx or UPS.
