

Required Documents Checklist

ALL TOURIST TRAVELERS must include the following documents in your package to G3:

- Your original valid signed passport. It must have at least one blank visa page and more than six months before expiry.
- Non-US citizens must provide a copy of their Alien Registration Card (A.R.C.) or U.S. Visa and original I-94.
- One completed and signed visa application form (two pages). Please ensure both pages are complete and signed.
- Two passport-style (2"x2") photographs taken within the last 6 months (must be on photo paper and have a plain white background).
- Copy of flight itinerary or confirmation letter from your tour operator.

NOTES:

These instructions are valid for tourist travelers only. If you require a Business or Flight Crew visa to Myanmar, please email info@g3visas.com for instructions.

Send all required documents and the completed Visa Order Form to G3 using a service with tracking such as FedEx or UPS.
