

## Required Documents Checklist

**ALL TRAVELERS must include the following documents in your package to G3:**

- Your original valid signed passport. It must have two blank visa pages facing each other and more than six months before expiry.
- Non-US citizens must provide a copy of their Alien Registration Card (A.R.C.) or original U.S. Visa and I-94.
- One completed and signed visa application form (see attached).
- One passport-style (2"x2") photograph taken within the last 6 months. It must be on photo paper and have a plain white background.
- Copy of flight itinerary

**BUSINESS TRAVELERS must also include:**

- A business letter from their U.S. company. This letter must explain the purpose of the trip and provide a financial guarantee. It must be on letterhead and signed by a representative of the company other than the applicant. A sample is attached.
- An invitation from the organization to be visited in Nigeria. Faxed or scanned copies are acceptable. A sample is attached.

**TOURIST TRAVELERS must also include:**

- A copy of hotel reservations, or an invitation letter from a private host in Nigeria, including a copy of the host's passport.

**OFFICIAL TRAVELERS must also include:**

- Official visa applicants must submit a letter from the U.S. Department of State stating the nature and duration of the visit. If applying for an Official visa you will need to submit your Official U.S. Passport (brown cover) NOT your Tourist Passport (blue cover).

**NOTES:**

For Residency (STR) or Temporary Work Permit (TWP) visas, please email [CLS@g3visas.com](mailto:CLS@g3visas.com) for current requirements.

The Embassy of Nigeria is closed every Friday. Friday is not counted as a processing day.

\*For visa requests requiring Mission Critical 3 Business Day processing, travelers must send a copy of their passport and visa application to G3 by email ([info@g3visas.com](mailto:info@g3visas.com)) or fax (703.524.3374) in advance of sending in the original documents. G3 must receive all original documents no later than 8:30 AM. Please send paperwork via FedEx or UPS with no signature required.

Please note: Embassy fees may vary according to nationality; citizens of some nations, including U.K., are subject to higher fees. Embassy Fees listed below include a \$5 Money Order fee.

Send all required documents and the completed Visa Order Form to G3 using a service with tracking such as FedEx or UPS.
